MINUTES FROM SEMIANNUAL MEMBERS MEETING February 21, 2021

The meeting was called to order at 5:57 PM by Pastor Rickey Primrose.

Old Business: The minutes from the August 3, 2020 regular meeting and the November 8, 2020 called meeting had been sent to the church membership in a previous email, and were presented for approval. Bob Brooks moved and Nelson McKinney seconded to approve these minutes; all members who wish to vote on this and other motions will do so through a link on the church website.

New Business: The list of names proposed to be removed from church membership due to letters out, erasures, and deaths were presented for approval and affirmation. Sarah Turner's name was asked to be moved from the erasures list to the letters to be granted list, and Ben and Gwladys Njoya's names were asked to be removed from the erasures list. Arden Brooks moved and Ethan Williams seconded the approval of the lists as amended. Voting will be done through the online link.

The list of proposed messengers to the 2021 SBC Annual Meeting in June, 2021 was presented for approval. Rickey Primrose was added to this list, and Richard Liebert moved and Annie Wong seconded the approval of the list as amended. Voting will be done through the online link.

With no other business to consider, Beverly Gooden moved to adjourn the meeting and Kathy Smithen seconded; the motion passed at 6:09 PM.

Pastor Bob Bolander gave the financial report at this time. The church was granted a PPP loan which was partially used to pay salaries during the COVID-19 shutdown, and which was later forgiven. Although attendance has been down 50% over this time last year, giving is only down 6.6%. The church's operating expenses were down as well due to the extended time it was closed, so this allowed the church to continue giving to missions at its regular level and remain in a strong financial position as well.

Video testimonies from the 21 Days of Prayer and Fasting were then presented, and Pastor Rickey announced that the second worship service will be relaunched on Palm Sunday, March 28 due to increased attendance. Worship services will be held at 8:15 and 11:00 AM, and community groups and equipping classes will meet at 9:45 to allow time to sanitize the worship center.

Pastor Travis Benge gave a report on upcoming leadership development, and Pastor Bob Bolander reported on continuing and upcoming missions opportunities.
